## **Drinking Water Quality**

The City of Pembroke is committed to providing its customers with the highest quality drinking water possible. We are proud to inform you that the City of Pembroke did not have any violations of water quality parameters during 2018. Our water continually meets or surpasses state and federal standards for safe drinking water. This annual water quality report will help inform you on where your water comes from, what it contains, and other information. The City of Pembroke has two wells which pump groundwater from the Upper Floridian Aquifer. We perform treatments at each of the wells to include chlorine disinfection and fluoride is added for tooth and bone development. also add Aquadene (Water Treatment Compound) corrosion control and prevent brown water. These wells pump water to 150,000-gallon elevated storage tank. The water then enters the distribution system for your consumption.

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include the following:

- Microbial contaminants, such as viruses and bacteria which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.
- Inorganic contaminants such as salts and metals, which can be naturally occurring or result from urban storm runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water runoff, and septic systems.
- Radioactive contaminants, which can be naturally occurring or be the result of oil and gas production and mining activities.
- If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Pembroke is responsible for providing high quality drinking water but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. To ensure that tap water is safe to drink, EPA prescribes regulations limiting the number of certain contaminants in water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottled water, which must provide the same protection for public health.

## Important Information About Your Drinking Water

Pembroke's City Council meets the second Monday of each month at 7:00 p.m. at City Hall. We urge our citizens to attend these meetings to stay abreast and active in the decision making of Pembroke's water.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk.
